# **OVERVIEW**

The College embraces a learning culture where excellence in the spiritual, academic, cultural and cocurricular areas is encouraged, recognised and celebrated. Relationships are the cornerstone of learning at Thomas Carr College and are central to the community's wellbeing.

The College's Sports Program reflects these value and aims to provide the opportunity for our students to participate in various sporting activities and to showcase their talents.

The position of Sport Leader is an important leadership position within the College in supporting the Principal and community to enact the mission and vision of the College.

Thomas Carr College is a member of the Sports Association of Co-educational Catholic Secondary Schools (SACCSS). Our sports program is an integral part of the College's co-curricular program and life of the College. The prime responsibility of the Sport Leader is to oversee the College's SACCSS sporting program and to provide opportunities for students to participate in the various sporting activities and major College sporting carnivals such as Swimming and Athletics.

# **KEY RESPONSIBILITIES**

#### **SACCSS EVENTS**

- Be responsible for the College's involvement in the SACCSS program at all year levels including all relevant competitions and tournaments.
- Foster a climate, which encourages students to participate in the College's SACCSS program across all year levels.
- Communicate with key staff including the Deputy Principal: International & Community Connections and Director of College Operations all calendared SACCSS events.
- Working closely with the Sports Assistant and staff from other schools involved in SACCSS, coordinate the organisation of SACCSS fixtures and venues.
- Working closely with the Sports Assistant, plan, organise and co-ordinate the participation of students in SACCSS events including the implementation of the SACCSS Code of Ethics and Behaviour and communication to families.
- Liaise with the Deputy Principal: Staff & Operations to oversee the staffing of all SACCSS events including emergency staff to cover any absent staff.
- Represent the College at SACCSS (Heads of Sport) meetings.
- Arrange for annual awards to be presented at College assemblies and other College events to recognise student involvement and achievements at SACCSS events.

## **COLLEGE EVENTS**

- Be responsible for the annual Swimming, Athletics and Cross-Country school carnivals.
- Working closely with other key staff, oversee and co-ordinate all House carnivals and other activities in the lead up to major school carnivals.
- Working closely with key staff and House Captains foster a climate, which encourages students to participate in the College's major sporting carnivals such as Swimming and Athletics.
- Liaise with the Director of College Operations to oversee the allocation of staffing for the College's major sporting carnivals such as Swimming and Athletics.
- Working closely with the Sports Assistant and other key staff oversee the booking of venues and all other requirements related to the planning and review of the annual Swimming, Athletics and Cross-Country school carnivals.



 Arrange for annual awards to be presented at College assemblies and other College events to recognise student involvement and achievements at the Swimming, Athletics and Cross-Country school carnivals.

## **STAFFING**

- With support from the Deputy Principal: Staff & Operations, be responsible for the employment and management of SACCSS Coaches that form part of the College's SACCSS program.
- With support from the Director of Staff Growth, oversee the induction program for all new SACCSS Coaches employed by the College.
- With support from the Director of Staff Growth, be responsible for providing professional learning opportunities for College staff and SACCSS Coaches to maintain their coaching accreditation and to build their capacity as coaches.
- Liaise with the Executive Assistant to the Deputy Principal: Staff & Operations to allocate all new staff a HOUSE.

#### **ADMINISTRATION**

- Work with other key staff to develop and maintain a system for recording student participation in all SACCSS events and other House activities to recognise individual student achievements that contribute to House Points.
- Oversee and manage the annual Sports budget.
- Working closely with the Sports Assistant, purchase and prepare equipment for all SACCSS fixtures and College sporting events including uniforms as per the College Style Guide.
- Working closely with the Sports Assistant, oversee the documentation of all the required Risk Assessments and other requirements for the approval of all SACCSS fixtures and major College carnivals.
- Monitor the behaviour of students participating in SACCSS and other sporting activities.
- Works in conjunction with the SACCSS Executive Officers to plan and implement allocated convening duties.
- Co-ordinate the organisation and presentation of all sport awards including attendance at SACCSS Awards.
- Contribute to College publications including online platforms to promote the College's Sport program.

#### **CHILD SAFETY**

- Be responsible for applying the College's Child Safety Policy and procedures including being compliant with the Child Safety Code of Conduct at all SACCSS events, training and other related activities.
- At all SACCSS events, training and other related activities, ensure SACCSS Coaches and other staff
  are proactive in reporting any concerns or identified risk, and they always monitor and support
  student wellbeing in a manner which reflects school values.

- Other College committees, as requested.

Through mutual agreement some variation in the specified responsibilities may take place during the term of appointment as a part of a normal process of ongoing evaluation of the College's operations.
